All eligible candidates who are interested for the same are requested to report at **09:30 AM** on **18.11.2024 at 5th Floor, Admn. Block**, along with **duly filled performa** annexed with this notice, a set of self-attested copies of all certificates, marksheets and two passport size photographs. **Original certificates/documents are also required at the time of interview for verification. Candidate's reporting after 11:00 AM will not be considered for the interview.**

Only those candidates are required to report who fulfill the eligibility criteria as Residency Scheme and following criteria.

- 1. Qualification:** BDS Degree from recognized University/Institute.
 - 2. Age Limit:** For General Candidates 30 years as on date of interview.
 - 3. Internship:** Must have completed one year rotatory internship after completion of BDS as on or after **18.11.2022**.
 - 4. Registration:** Candidates must have valid registration certificate of DDC/State Dental Council as on date of interview. **Applications forms without DDC/State Dental Council Registration Certificate or with 'Applied For' status shall not be considered.**
 - 5. Pay Scale:** The pay matrix of Level - 10 (Rs. 56100-177500), plus other usual allowance as admissible under the residency rules.
 - 6. Tenure:** The tenure of Junior Resident is purely on **adhoc basis initially for a period of 89 days** and extendable upto maximum of one year subject to satisfactory work conduct report and vacancy or till regular candidate join, including any service rendered as Junior Residency earlier on **adhoc/regular basis** in any recognized government institution.
- *Candidate must not have completed one year Junior Residency in any Govt. Institute/Hospital in India on Regular or Adhoc basis.**


GENERAL TERMS AND CONDITIONS

- 1) Number of the vacancies may vary.
- 2) Reservation of PH Category as per rule.
- 3) Selection/appointment is purely on provisional basis, subject to verification of educational certificates and other related certificates/antecedents/DDC certificate and the candidate being found medically fit.
- 4) The service condition will be regulated as per the rules in the Residency Scheme, Ministry of Health & Family Welfare, Govt. of India.

- 6) **NO TA/DA will be paid to the candidates called for the interview.**
